## DR-Foundry End User Licence Agreement 2017

## **General Terms**

This agreement is between you "user"/"licensee" and Daniel Reed (DR-Foundry).

- You may not sell, lend, sub-license or transfer rights of DR-Foundry typeface(s) under this agreement to any person, or third-party.
- Once purchased you become a licensed user not an owner of the file. Purchased typeface(s) will always remain copyright to DR-Foundry.
- Any alterations to the typeface(s) are strictly prohibited. Any alterations that are required must only be carried out by DR-Foundry. Please contact Daniel Reed to discuss this in more detail (hello@daniel-reed.co.uk).
- DR-Foundry does not permit refunds for any typeface(s), all purchases are final, unless it is proven that the files are damaged.
- All licences are non-transferable. This means licences cannot be transferred to clients once work has been completed using the typeface(s). Clients must purchase their own copy of the licence, but you can purchase on behalf of the client if necessary.
- Although every effort has been taken to check the typeface(s) for viruses, DR-Foundry does not take responsibility for damage caused to a user's hardware, software or a loss of income. All typeface(s) are installed at the owner's risk and DR-Foundry will not be held responsible.
- Licence conditions must be communicated internally. For example, if you are limited to five licences, please make sure that the licence is extended if more users are to be added.
- DR-Foundry reserves the right to ask you for a copy/proof of your licence at any time.
- Failure to comply with these conditions will result in the immediate termination of your licence, DR-Foundry
  reserves the rights to terminate your licence for the purchased typeface(s) without refund. After termination, you
  must delete all copies of your typeface(s), including backups or copies stored on external drives.

## **Desktop Terms**

- The purchase of a typeface(s) is for the number of users licensed for. Users must work for the same company within the same location.
- Under no circumstances can the (OTF) file be converted to any other file formats.
- The purchase of a typeface(s) makes the buyer a licensed user of the typeface(s), not an owner. The desktop licence allows the user to use the typeface(s) on a desktop machine, on applications such as: logos, publications, editorial, images for social media and websites.
- Typeface(s) licences are non-transferable and are licensed to the original buyer.

## **Webfont Terms**

- The licensed Webfont(s) can be used on any website owned or managed by the licensee. The total traffic, measured in page views per month, which the licensed Webfont is used must be no greater than the number of page views per month selected when you completed checkout.
- Page views per month is the number of views of all pages on a single website. If the website exceeds this, you must inform DR-Foundry.
- The supplied Webfonts (WOFF) cannot be use to create bitmap or vector designs. The licence only allows for the rendering of live text on a digital platform, a desktop licence must be purchased if static images for the website are to be created.
- Each licence is for use on one domain and is non-transferable. You may extend/upgrade your licence to include more domains if necessary.
